Auditors Report

I have audited the attached statements of accounts of the **Swami Ramanand Teerth Marathwada University**, **Nanded** as on **31**st **March**, **2014** and I report subject to general remarks that.

- a] I have obtained all the information and explanation which to the best of my knowledge and belief were necessary for the purpose of audit.
- b) the proper books of accounts have been maintained as required by the Maharashtra Universities Act, 1994 and rules.
- c] all books of accounts, vouchers and other documents and records required by me were produced before me for the purpose of audit.
- d] the inventory of the movable of the University is maintained by the University.
- e] the Balance Sheet and Income & Expenditure Account prepared as per Maharashtra Universities Account Code Format, examined by me are in agreement with the books of accounts, and returns maintained by the University.
- f] in my opinion and to the best of my information and according to the explanation given to me the said accounts give true and fair view
 - i] in the case of Balance Sheet of the state of affairs of the University as on 31st March, 2014.
 - ii] in the case of Income & Expenditure Accounts, the surplus of the University for the period ended on that date.

General Remarks

01. Income Leakages

We had suggested in our previous audit report that there must be effective and proper system of reconciliation to ensure that income from various fees like Affiliation Fees, Sports Fees, Students Welfare Fees and Eligibility Fees etc. are recovered promptly. Reconciliation statement is yet not produced for our verification by concerned department. It has been observed that Income Leakages committee has been formed but Reconciliation Statement has not been produced for our verification by the concerned Departments.

02. Departmental Reporting

There is no change in our remark in previous audit report that with the growth of our university, it is now felt that there must be effective reporting system from various Departments to Accounts Department. All departments reports shall be submitted to Departmental Reporting Committee (DRC) under a standard format. Departmental Reporting Committee (DRC) will consolidate the various reports and then submit it to the Accounts Department with its suggestions, if any.

Information will flow in following pictorial direction:



<u>Departmental reporting will consist of following information:</u>

- [i] Coursewise collection of Fees and its deposit to Accounts Department
- [ii] Details of Scrap and breakages with its disposal, if any.
- [iii] New Instrument or equipment installation report is to be submitted with details like date of purchase and date of installation, if any.
- [iv] Report of regarding Usage/Reading/Handling of a particular scientific instrument is to be made.
- [v] Various equipments and instruments given to employees of departments for their individual use shall be reported and it shall be presented for physical verification before the DRC at least once in the year and duly certified about its existence.

03. Fuel Utilization Register

In verification of Log Books of vehicles, we have found that under the column of particulars for usage of vehicle 'Guest' is written. Name of Guest shall be mentioned.

Monthly summary of usage of fuel, run in Kms and fuel average is to be mentioned at the end of every month.

Fuel Consumption Average

It has been observed by us that Fuel Consumption Average of all types of vehicle is allowed @ 10 Kms per liter. We could not find any rule in this connection. Now-a-days with technological development most of the vehicles have developed there fuel efficiency and therefore, fuel consumption is at least @ 15 Kms per liter. In our opinion, latest vehicles are available with University having better fuel efficiency. But we found that still fuel consumption claimed by drivers is @ 10 Kms per liter.

Therefore, we suggest that a Technical Committee is to be established to determine the Vehicle wise standard fuel average. **STANDARD FUEL AVERAGE** determined by Technical Committee shall be binding on every vehicle driver.

There is no change in our remark in previous audit report therefore we suggest that for control over the fuel expenditure it is necessary to maintain Fuel Utilization Register for Vehicles and Generator usage.

04. Vehicle Maintenance Expenditure

In our opinion, University may introduce Vehicle Allowance system instead of running own vehicles for various officers. This will ultimately reduce the recurring cost of Running and Maintenance of Vehicles and fixed cost on the same.

05. Civil Works Verification

Building Register is not up dated by concerned department.

<u>Civil works in connection with Grant received from UGC or State Government</u>

While going through the sanctioned documents by UGC or State Government it has been found as under:

- a. Time period specified by works order is never followed.
- b. Expenditure is more than Tender Cost.
- c. Expenditure incurred on civil works is not in accordance with the guidelines specified by the concerned sanction authority either UGC or State Government. This has ultimately resulted into extra burden on the funds of University. For example, electrification expenses are not incurred out of funds sanctioned or received. In most of the cases, electrification and other expenses are borne by University out of its own funds which would have been incurred from the funds of UGC or State Government.
- d. In case of excessive expenditure on particular project sanctioned by concerned authority we found that excessive expenses are incurred by University out of its own funds. We demanded permission taken from concerned authority i.e. State Government or UGC but it was not produced for our verification.

Excess and Extra Quantity

It has been observed that there is excess quantity than mentioned in estimates and also extra items which were not part of estimates. There shall be control of Architect and Engineer on the estimates. Explanation in respect of variation was asked by us but there was no explanation given to us during the course of our audit proceedings.

06. Stock Verification

Departmental Dead Stock Register is not maintained properly. Physical Verification Report by various departments have not been produced for our verification.

07. Accounts Department

It has been observed that Department has maintained manual as well as computerised books of accounts. Special Application System must be acquired for complete computerized accounting.

Bank Balances are subject to Bank Reconciliation Statement.

Financial Statements are prepared as per Maharashtra Universities Account Code Format.

Accounts are regrouped and reclassified wherever required. We have followed Concept of Materiality in our reporting.
