INDEPENDENT AUDITOR'S REPORT

Report on the Financial Statements

We have audited the accompanying financial statements of SWAMI RAMANAND TEERTH MARATHWADA UNIVERSITY, NANDED which comprise the Balance Sheet as at March 31, 2021, and the Income and Expenditure Account for the year then ended, and a summary of significant accounting policies.

University Responsibility for the Financial Statements

University is responsible for the preparation of these financial statements that give a true and fair view of the financial position, financial performance in accordance with applicable Accounting Standards. This responsibility includes the design, implementation and maintenance of internal control relevant to the preparation and presentation of the financial statements that give a true and fair view and are free from material misstatement, whether due to fraud or error.

Auditor's Responsibility

Our responsibility is to express an opinion on these financial statements based on our audit. We conducted our audit in accordance with the Standards on Auditing issued by the Institute of Chartered Accountants of India. Those Standards require that we comply with ethical requirements and plan and perform the audit to obtain reasonable assurance about whether the financial statements are free from material misstatement.

An audit involves performing audit procedures to obtain audit evidence about the amounts and disclosures in the financial statements. The procedures selected depend on the auditor's judgment, including the assessment of the risks of material misstatement of the financial statements, whether due to fraud or error. In making those risk assessments, the auditor considers internal control relevant to the preparation and fair presentation of the financial statements in order to design audit procedures that are appropriate in the circumstances, but not for the purpose of expressing an opinion on the effectiveness of the entity's internal control. An audit also includes evaluating the appropriateness of accounting policies used and the reasonableness of the accounting

estimates made by university, as well as evaluating the overall presentation of the financial statements.

We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our qualified audit opinion.

Basis for Opinion

In our opinion and to the best of our information and according to the explanations given to us, except for the possible effects of the matter described in Emphasis of matter paragraph, the financial statements give the information required by the Act in the manner so required and give a true and fair view in conformity with the accounting principles generally accepted in India:

- (a) In the case of the Balance Sheet, of the state of affairs of the University as at March 2021;
- (b) The case of the Income and Expenditure Account, of the surplus for the year ended on that date.

Emphasis of Matter

we draw your attention in following matter

1. Considering volume of transactions of university it is recommended to have Internal audit system in place timely correction of mistakes in working operations of the university.
2. University is recommended to check status of GST registration of various vendor of university before making payment of GST to such vendors as we observed that few parties GSTIN was inactive or cancelled but payment of GST is made to such parties.
3. The internal control especially in following areas needs to be strengthened so as to make them commensurate with the size of the university and the nature of its activities.
 - i. It has been observed that University is collecting fee such as examination forms, affiliation process, external admission, Post graduate admission on the campus, Pro-rata collection, eligibility, hostel admission etc. from students However, from the internal control point of view, the system needs improvement for getting the information in respect of the outstanding dues either from the colleges or from the student at the end of





each financial year, in the present system there is no record of outstanding receivables available for verification from students or colleges affiliated with university.

ii. Latur Sub-centre of the university is collecting cash from students and deposits cash in the bank which is around 17 Km away from university premises in such cash transit insurance is necessary but same was not taken by university hence it is recommended to get insurance with immediate effect so that future unfavourable events can be avoided.

Report on Other Legal and Regulatory Requirements

i. We have obtained all the information and explanations, which to the best of our knowledge and belief was necessary for the purpose of our audit subject to our observations in Emphasis of Matter Paragraph above.

ii. In our opinion proper books of account as required by law have been kept so far as it appears from our examination of those books.

iii. In our opinion the Balance Sheet and the Income and Expenditure Account dealt with by this report comply with the requirements of the Maharashtra Universities Account Code.

iv. The Balance Sheet and the Income and Expenditure Account dealt with by this report are in agreement with the Books of accounts.

Significant Accounting Policies forming part of the financial statements

1. Accounting Convention

The financial statements are prepared on the basis of historical cost convention and generally on the cash basis of accounting.

2. Revenue Recognition

Fees from students/colleges, interest on savings bank account and Interest /dividend on investments are accounted for on cash basis as and when they are received.

3. Government Grants

a. Central Government UGC/CSIR/RUSA/XII Plan Grants/Research and Innovation project grants other funding agency grants are accounted for on cash basis.

b. To the extent utilized towards capital expenditure, Grants received from funding agency are not transferred to the Capital Fund and lying in the Grant received ledger under the head current liabilities.

c. Grants received from granting agencies such as RUSA, Covid-19 Grant, BIRAC New Delhi, DST Inspire Fellowship, ICSSR Project Grant, ITDP Scheme Kinwat, National Commission for Women's, TRTI Project Pune, Various Fellowship Grants (DST), Various Fellowship Grants SERB towards capital expenditure and revenue expenditure during the current financial year except for salary expenditure grant.

4. Inventory Valuation

Inventories are valued at cost or market value whichever is lower.

5. Fixed Assets

a. Fixed assets are stated at written down value. Depreciation is charged as per schedule No. BS-5 attached below.

b. Work in Progress (Buildings): Expenditure incurred on buildings under construction as on the end of this financial year has not been shown separately

c. Fixed Assets purchased out of Grants: Fixed Assets purchased during the year from grant of Funding Agencies has been shown separately in Schedule "BS-5" to Balance Sheet.



6. Depreciation

Depreciation is charged as follows:

- University has not charged Depreciation on books and magazines from the date of inception and same is appearing at purchase cost in fixed assets.
- Depreciation is charged on addition of assets and payment dates are considered as Addition date and for depreciation calculation instead of Date of put to use of Asset.

7. Retirement Benefits

- a. Leave encashment is accounted for on cash basis.
- b. Provident fund is paid to retired employees after the receipt from state government and is accounted for on cash basis.

8. Investments

- a. Investments are valued at cost and interest income is accounted on receipt basis in the books of accounts.
- 9. Salary Expenditure from government grants as well as from university funds has been shown separately in the income and expenditure account.



Contingent Liabilities and Notes to Accounts

1. Contingent Liabilities

Record of Various claims against university filed by employees, outsiders and government department (Revenue Department) is not provided for our verification hence we cannot ascertain the amount of liability that may arise in future.

2. Taxation

The income of university is exempt from Income Tax under Section 10(23C) (iii ab) of the Income Tax Act. As well as university is having registration u/s 12(AA) of the Income Tax Act.

3. Current Assets, Loans & Advances

In the opinion of the university, the current assets, loans & advances have a value of realisation in the ordinary course, equal to the aggregate amounts shown in the balance sheet but balance confirmation statements are not available with university hence same is not confirmed by the parties.

Suggestions

1	Register of Fees Collection Record and files of sports proposals does not have Index hence it takes time to search college in the register and also in file so it is requested to maintain register and files with Index.
2	Sports department equipments stock register is not maintained it is advised to maintain all Sports Equipments list so that it can be verified physically and there will be control of department on its stocks and any deviations can be found out immediately on physical stock verification.
3	For More control on access to Indoor Sports hall it is advised to have Automatic door lock system and every member who has taken subscription will be given a card for entering the hall, the card provided to member will be scanned at the time of entry and door will open automatically. and if any members subscription period is expired then card will automatically block his entry and his card will become inoperative and will become active when he pays his subscription fees. Such system should be implemented for more secure access to Indoor sports Hall.
4	University has made a huge investment in Purchasing Gym Equipments but these equipments are unused till date it is advised to open gym for all considering COVID 19 guidelines from time to time so the revenue from subscription will also increase to the university.
