**Educational Qualification for Assistant Professor:**

**Eligibility (A or B):**

**A.**

i) A Master degree with 55% marks (on an equivalent grade in point table scale wherever grading system is followed) in concerned /relevant /allied subject from an Indian university or an equivalent degree from an accredited foreign university.

ii) Besides fulfilling the above qualifications, the candidate must have cleared the National Eligibility Test (NET) conducted by the UGC, or the CSIR, or a similar test accredited by the UGC like SET or Who are or have been awarded a Ph.D degree in accordance with the university grant commission (minimum standard the procedure for award of M.Phil./Ph.D. degree) regulations 2009 or 2016 and their amend-ments from time to time as the case may be exempted from NET/SET:} provided candidates registered for the Ph.D. programme prior to July 11,2009 shall be govern by the provisions of the then existing ordinance/ by laws/Regulation of the institutions awarding the degree and such Ph.D.candidates shall be exempted from the requirement of NET/SET for recruitment and appointment of assistant professor or equivalent positions in university/colleges/instructions subject to the fulfillment of the following conditions:

- The Ph.D.degree of the candidate has been awarded in regular mode only;
- The Ph.D. thesis has been evaluated by at least two examiners;
- An open Ph.D. viva voce of the candidate has been conducted
- The candidate has published two research papers from his/her Ph.D. work in out of which at least one is in a refereed journal ; and
- The candidate has presented at least two papers,based on his/her Ph.D. work in conferences / seminars,sponsored/funded/supported by the UGC/CSIR/ICSSR or any similar agency.

**Note:**

- The fulfillment of these conditions is to be certified by registrar or the dean(academic affairs) of the university concerned.
- NET/SET shall also not be required for such master's programmes in disciplines for with NET/SET is not conducted. However, Ph.D. degree shall remain the minimum eligibility for appointment of Assistant Professor in such disciplines.

The academic score as specified in Appendix II (Table 3A) for universities And appendix II (Table 3B) for college, shall be considered for short-listing of the candidates for interview only, and the selections shall be based only on the performance in the interview.

**Educational Qualification for College Librarian:**

- i) A master's Degree in library science/information science or an equivalent professional degree, with at least 55% marks (or an equivalent grade in a point scale wherever the grading system is followed).
- ii) A Consistently good academic record, with knowledge of computerization of a library.
- iii) Besides fulfilling the above qualifications, the candidate must have cleared the National Eligibility Test (NET) conducted by the UGC or the CSIR, or a similar test accredited by the UGC, like SET or who are have been awarded a Ph.D. degree in accordance with the University Grants Commission (Minimum Standards and Procedure for Award of M.Phil./Ph.D. Degree) Regulation, 2009 or 2016 and their amendments from time to time as the case may be. Provided that, the candidates registered for the Ph.D. programme prior to July 11, 2009, shall be governed by the provisions of the then existing Ordinance/Bye laws/ Regulations of the institutions awarding the degree and such Ph.D. candidates shall be exempted from the requirement of NET/SET for recruitment an appointment of assistant professor of equivalent positions in Universities/Colleges/Institutions subject to the fulfillment of the following conditions:

- i) A Master's Degree in Physical Education and sports or Physical education or sports Science with at least 55% marks (or an equivalent grade in a point scale wherever grading system in followed).
- ii) Record having represented the University/College at the inter University/inter collegiate competitions or the state and/or national championships.
- iii) Besides fulfilling the above qualifications, the candidate must have cleared the National Eligibility Test (NET) conducted by the UGC, CSIR, or a similar test accredited by the UGC, like SET or who are have been awarded a Ph.D. Degree in accordance with the University Grants commission (Minimum Standards and Procedure for Award of M.Phil./Ph.D. Degree) Regulations, 2009 and their amendments from time to time as the case may be.  
 Provided that, the candidates registered for the Ph.D. degree prior to July 11, 2009, shall be governed by the provisions of the then existing. Ordances/Bye-laws /Regulations of the institutions awarding the degree and such Ph.D. candidates shall be exempted from the requirement of NET/SET for recruitment and appointment of Assistant Professor or equivalent position in Universities/Colleges/Institutions subject to the fulfillment of the following conditions:

- 1) NET/SET shall also not be required for such master's programmes in disciplines for which NET/SET is not conducted. However, Ph.D. Degree shall remain minimum eligibility for the appointment in such disciplines.
- 2) Passed the physical fitness test conducted in accordance with these rules.


