- i) A Master degree with 55% marks (on an equivalent grade in point table scale wherever grading system is followed) in concerned /relevant /allied subject from an Indian university or an equivalent degree from an accredited foreign university.
- ii) Besides fulfilling the above qualifications, the candidate must have cleared the National Eligibility Test (NET) conducted by the UGC, or the CSIR, or a similar test accredited by the UGC like SET or Who are or have been awarded a Ph.D degree in accordance with the university grant commission (minimum standard the procedure for award of M.Phil./Ph.D. degree) regulations 2009 or 2016 and their amendments from time to time as the case may be exempted from NET/SET:} provided candidates registered for the Ph.D. programme prior to July 11,2009 shall be govern by the provisions of the then existing ordinance/ by laws/Regulation of the institutions awarding the degree and such Ph.D. candidates shall be exempted from the requirement of NET/SET for recruitment and appointment of assistant professor or equivalent positions in university/colleges/instructions subject to the fulfillment of the following conditions:

The academic score as specified in Appendix II (Table 3A) for universities And appendix II (Table 3B) for college, shall be considered for short-listing of the candidates for interview only, and the selections shall be based only on the performance in the interview.

Educational Qualification for College Librarian:

- i) A master's Degree in library science/information science or an equivalent professional degree, with at least 55% marks (or an equivalent grade in a point scale wherever the grading system is followed).
- ii) A Consistently good academic record, with knowledge of computerization of a library.
