GUIDELINES FOR ORAL PRESENTATION

Each oral presentation will be provided 5 minutes followed by 2 minutes for discussion. Participants need to submit presentation in templates provided by the organizers.

- Maximum 10 slides can be presented. Each one slide for, Title, Introduction & Need for the study, Aims & Objectives, Materials & Methods, Summary & Conclusion, Acknowledgment & References and four slides for Results and Discussion.
- Presentation (.ppt/.pptx) slides must be submitted to vishwapharma2022@gmail.com on or before 4.00pm of 25th September 2022 without fail.
- Failure to Submit / Late Submission strictly will not be entertained.
- Only genuine research work will be accepted for oral presentation.

POSTER SPECIFICATION

The size of poster presentation will not be more than 0.95 mtr (95 cm) width by 1.2 mtr height (120cm). The title of the poster should cover the full width of the poster. The title should be brief, informative and written in bold letters, the size of letter should be such that a viewer can read it from 2 meter distance.

The message should be clear, understandable and self explanatory. Each participant will be provided with specific entry code from the concern discipline and are instructed to hide their institute's identity during presentation.

The participants are also instructed to introduce to the panel of judges with their code only without referring the college or personal names or even showing their identity cards.

MODEL SPECIFICATION

1. Model making is solely reserved for second year students of D. Pharm, B. Pharm, Pharm-D of Academic Year 2022-23.
2. Participant will get 4 x 4 Sq. ft area for Model Presentation.
3. Participant should make short keys for their Presentation.
4. The Model should be strictly based on Pharmacy field.

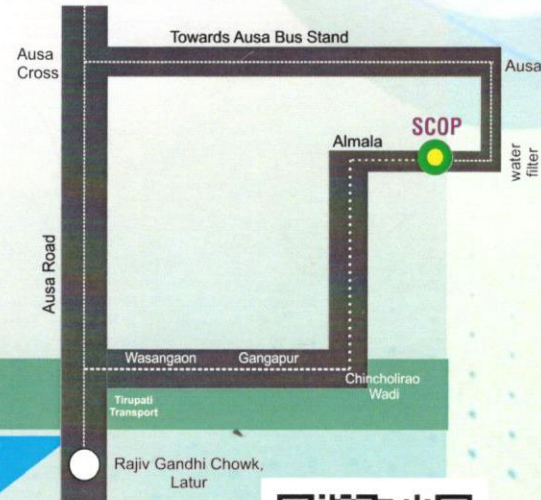
