To prevent ragging, UGC has framed regulations on curbing the menace of ragging in higher educational institutions. These regulations are mandatory, and all institutions are required to take necessary steps for its implementation in toto including the monitoring mechanism as per provisions in the above regulations and ensure its strict compliance. The UGC has also taken several proactive steps including the effective launch of a Media Campaign for preventing ragging. Films in ragging are also uploaded on UGC website for use by higher education institutions.

As a step further, UGC has decided that Anti Ragging Day would be observed on 12th August followed by Anti Ragging Week from 12th August to 18th August. This initiative is one of the tools of the Commission in increasing awareness against ragging. It is further desired to adopt the following activities during the celebration of Anti Ragging Day/Week:

- Introduction/Orientation programmes on Anti Ragging.
- Conduct various competitions such as slogan & essay writing, poster making, and logo designing on Anti Ragging and distribute certificates/prizes to encourage the students/faculty/non-teaching staff to promote Anti Ragging.
- Events like Anti-Ragging workshops, seminars and other creative avenues to spread the idea.
- TVCs, short films and documentary movies may be shown to students and faculty. (Available on UGC websites i.e. www.ugc.ac.in & www.antiragging.in).


To prevent ragging, the UGC has framed regulations to curb this menace in higher education institutions. These regulations are mandatory, requiring all institutions to take necessary steps for full implementation, including a monitoring mechanism as stated in the regulations, and to ensure strict compliance. The UGC has also taken several proactive measures to raise awareness about preventing ragging in higher education institutions.

In observance of Anti-Ragging Day on 12 August, followed by Anti-Ragging Week from 12 to 18 August, the UGC and Centre for Youth (C4Y), the UGC National Anti-Ragging Monitoring Agency, suggest further activities during these celebrations:

1. Use the hashtag **#YaARIYouthAgainstRagging** in all your activities and social media posts related to celebrating Anti-Ragging Day/Week, and tag UGC and C4Y (social media accounts are provided below).

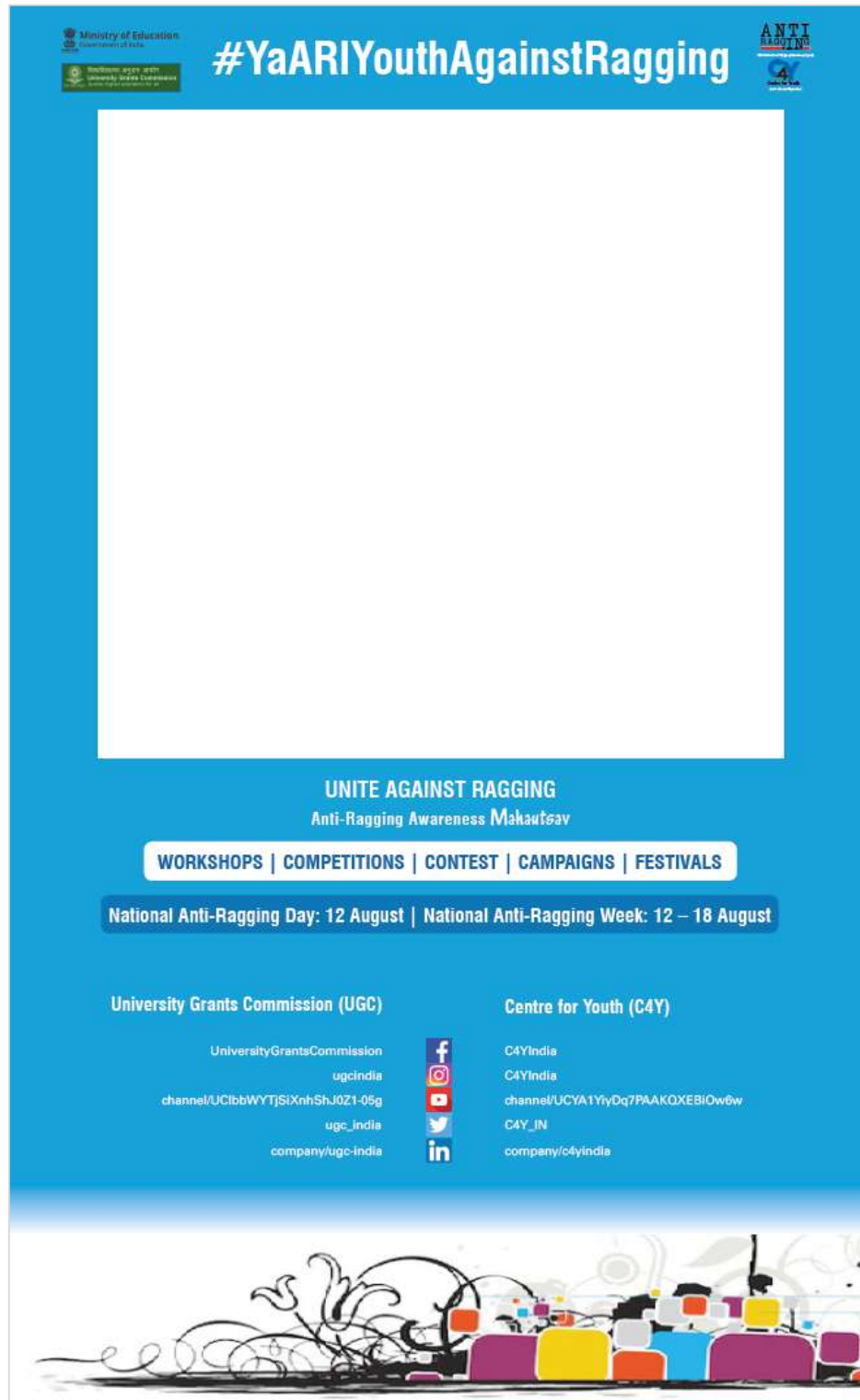

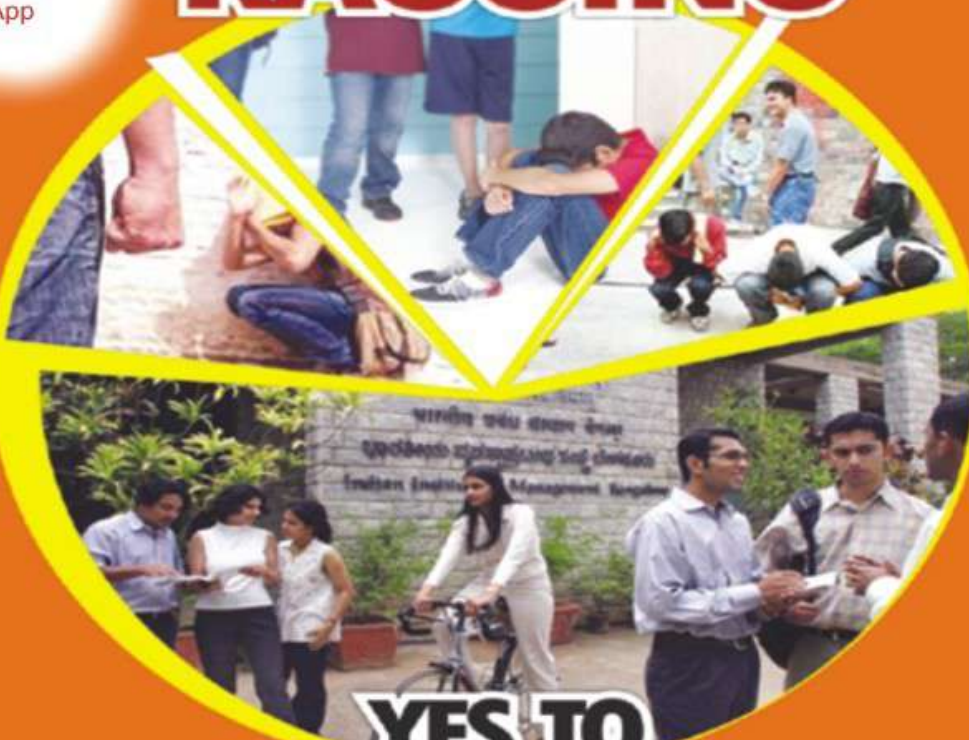

- Cancellation of admission.
- Suspension from attending classes.
- With holding/ withdrawing Scholarship Fellowship and other benefits.
- Debarring from appearing in any test/ examination or other evaluation process.
- With holding results.
- Debarring from representing the Institution in any regional, national or international meet, tournament or youth Festival etc.
- **Collective punishment** : when the persons committing or abetting the crime of ragging are not identified the institution shall resort to collective punishment as a deterrent to ensure community pressure on potential ragger.

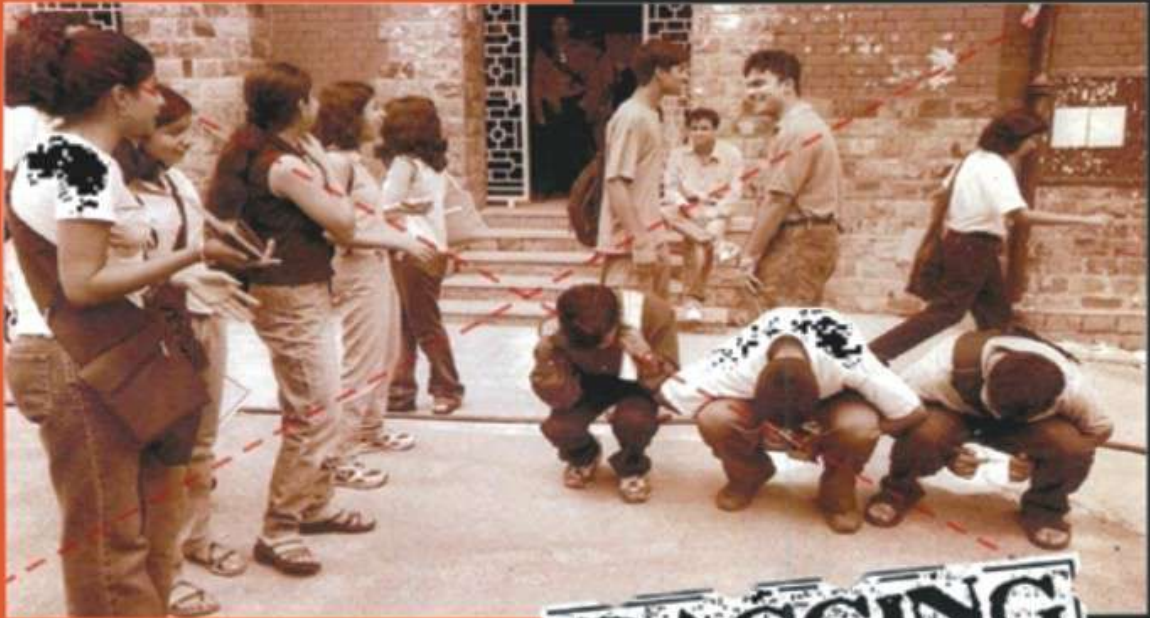

कामाच्या ठिकाणी होणारा महिलांचा लैंगिक छळ प्रतिबंधक कायदा २०१३

* कायदा काय सांगतो...

- * लैंगिक छळ म्हणजे नकोसा शारीरिक संपर्क आणि लगट, लैंगिक वर्तणुकीची मागणी किंवा विनंती, लैंगिक शेरबाजी, पोर्नोग्राफी दाखविणे, शारीरिक किंवा शाब्दिक किंवा हुतर प्रकारे नको असलेले लैंगिक वर्तन करणे.
- * कलम ३ (२) कामाचे ठिकाण म्हणजे शासकीय, निमशासकीय, अशासकीय किंवा खाजगी नियंत्रणाखाली असलेले कोणतेही कार्यालय, संघटन, संस्था, डिपार्टमेंट, स्वयंसेवी संस्था, सहकारी संस्था, हॉस्पिटल, नर्सिंग होम, क्रीडा संस्था, स्टेडियम, कामाच्या ठिकाणी पोहचविणारे वाहन, असंघटीत क्षेत्र, निवासाचे ठिकाणी अथवा घर होय.
- * संबंधित महिलेला रोजगारात प्राधान्य देण्याचे उघड वा छुपे वचन, कामात अडथळे, रोजगाराला धोका, भयप्रद, अपमानास्पद वागणूक याही कृती लैंगिक छळात अंतर्भूत आहेत.
- * अंतर्गत तक्रार निवारण समितीच्या ५०% सदस्या महिलाच असाव्या आणि अध्यक्षही महिलाच असायला पाहिजे.
- * समितीकडे लैंगिक छळ झालेल्या महिलेला लेखी किंवा तोंडी तक्रार करता येते.
- * तक्रार प्राप्त झाल्यानंतर, तक्रारकर्त्याच्या मतानुसार समझोता होत असल्यास त्यासाठी सर्वप्रथम समिती प्रयत्न करेल पण समझोता झाला नाही तर ज्या व्यक्तीकविरुद्ध तक्रार प्राप्त झाली आहे, त्याची चौकशी करण्यात येईल.
- * जर मालकाने अथवा जबाबदार अधिकाऱ्याने महिला तक्रार समिती स्थापन केली नाही अथवा स्थापन झाल्यावर आलेल्या तक्राराची नोंद, चौकशी आणि सूचना यांचे पालन व्यवस्थित न केल्यास त्यास रुपये ५०,०००/- दंड होऊ शकतो.
- * अपराध सिद्ध झाल्यास अपराध्याविरुद्ध शिस्तभंगाची कार्यवाही होऊ शकते. भारतीय दंड विधान कायद्याच्या विविध कलमांतर्गत अपराध्यास शिक्षा होऊ शकते.
